# 2021 Pat Weston Memorial Scholarship

## **SCHOLARSHIP DESCRIPTION**

The California Transportation Foundation (CTF) and the California Department of Transportation, Planning programs are offering one \$850 scholarship to fulltime Caltrans employee. The employee must be employed with Caltrans for a minimum of six months, and must be pursuing a degree in Transportation Planning or a related field.

This scholarship is intended to recognize, encourage, and assist outstanding Caltrans employee who are pursuing a Baccalaureate or Graduate degree in planning or a related field.

This scholarship is competitive and is based on:

- Employment record
- Academic record
- Personal statement

## **ELIGIBILITY REQUIREMENTS**

To be eligible for this scholarship, the applicant **must** meet the following criteria:

- Working towards a baccalaureate or a graduate degree in Transportation Planning, Urban Planning, or City or Regional Planning. Related fields of studies such as: Urban or Regional Studies, Public Policy, Public Administration, Environmental Policy or Studies, Geography, Sociology, Political Science, Landscape Architect, or Economics will also be considered
- 2) Must have worked for Caltrans for a minimum of six months
- 3) Student must have a cumulative GPA of 3.0 or better
- 4) Recipients cannot receive more than one award from this scholarship
- 5) Pursuing a career at Caltrans in Transportation Planning after graduation

## APPLICATION MATERIALS

### Each applicant must submit the following materials:

- 1. A completed Division of Transportation/ CTF Scholarship Application.
- 2. An essay outlining career goals (not to exceed 500 words)
- 3. An official college or university transcript
- 4. Proof of current college/ university enrollment
- 5. A minimum of two sealed letters of recommendation
  - One from faculty
  - One from a current supervisor

The Pat Weston Endowment Scholarship Selection Committee will review all applications. After careful review, the winners will be notified.
